Fresh NOTICE INVITING TENDER NO.06 of 01/2017

For and on behalf of Governor of Jammu and Kashmir state the Executive Engineer, Ravi canal Const. Upper Division Kathua hereby invites sealed tenders on the prescribed tender form valid for 90 days through Regd. Post/Speed post/Courier service from the eligible approved P.W.D Contractor/Firms (Registered by the J&K Govt.) for the below mentioned works. The tenders should be affixed with Rs.6.00 revenue stamps and accompanied by 2% earnest money in the shape of CDR duly pledged in favour of Executive Engineer, Ravi Canal Const. Upper Division Kathua. The tender documents can be purchased from the office of the Executive Engineer, RCC Upper Division Kathua against the cash payment for Rs.200/- (non refundable) S.No.1 to-6 &Rs.300/- for S.No.7 from 27-01-2017 to 30-01-2017 The tenders shall be opened on 31-01-2017 at 03.00 PM or any other subsequent date convenient to the tender opening authority in presence of such tenderers who may like to be present at the time of opening of the tenders

The Contractor shall quote their rates **above or below** both in words/figures without cutting/overwriting and rates should be covered with transparent tape. The tenders without transparent tape on the rates shall be out rightly rejected. The rate list of the works along with the terms and conditions are attached with the NIT. The tenders received late due to postal delay or due to any other reasons shall be responsibility of the tenderer(s) concerned and further all such tenders shall be rejected. The tenderers are advised to visit the site and read carefully "General conditions and the special conditions" of the NIT well before they offer their rates. The tender opening authority reserves himself the right to accept/reject any or all tenders without assigning any reasons thereof.

The work shall only be allotted to the lowest tenderer only after availability of funds.

Terms and conditions

1-All printed conditions enclosed with the tender/Tender document as well as P.W.D form 25- D shall be binding upon the tenderers.

2-Conditional tenders shall not be entertained/accepted.

3-The Deptt. material shall be issued to the contractors i.e. cement @ Rs.460/-per bags on cash payment if available and steel @ Rs.6000/-Qtl. shall be recovered from the bill of the contractor.

4-The tenders should attach photocopy of Regd. card duly renewed for the current year.

5-The tender documents/rate list for the mentioned works can be seen in the office of the undersigned on any working days.

6-Tenderer should attach photocopy of his pan No. Tine No.& Service clearance certificate

7-Written approval of the competent authority shall be necessary to be obtained if during execution of work ,qty. of any item of work got increased over the NIT/Agreement quantity due to change of proposal as per requirement at site of work

8-The service tax on gross amount payable to the Contractor which also includes cost of material shall be deducted as per Govt. instructions/as per standing Governments orders.

9-The contractor who tendered such rates which will be found un-workable i.e. reasonable below or high shall not be accepted.

10-Allotment shall be made only after receipt of funds otherwise tenders deemed to be cancelled after expiry of Ninety days.

11-Misconduct/Misbehavior, if any observed during the tender opening process with any officer /official shall debar the contractor for allotment of work and shall be liable for cancellation of registration card issued by any Department.

12-1% WORKER WELFARE CESS SHALL BE CHARGED EXTRA FROM THE PAYMENT OF THE CONTRACTOR IF APPLICABLE

- 13-In case the contractor is found unreasonable i.e. 15% below the advertised cost, the contractor shall have to submit additional security of 5% (which shall be released only after completion of 70% of the work) of contract amount in shape of FDR/CDR along with contract, failing which the tender shall be rejected.
- 14-The contractor will provide cubes/moulds of 15x15x15 cum during execution of work which are required to be cast for concrete being used by the contractor and get them tested to know the seven days and twenty eight days test to ascertain the quality of concrete. The expenditure for testing of cubes shall be borne by the contractor .Satisfactory results are mandatory for making payment to the contractor
